Some of his representative experience includes:

- Successfully defended large dairy cooperative in attempt by Chapter 11 Trustee in Arizona to sell to third parties millions of dollars of client's capital, potentially to be allocated to debtor in bankruptcy contrary to the client's policies and programs
- Successfully defended agricultural food processor in a New Mexico lawsuit brought by a secured creditor to enforce a security interest in the client's capital by preventing client from offsetting six figure amounts due and owing from debtor to client pursuant to express agreements between the client and debtor
- Defended large dairy cooperative in multimillion-dollar preference complaint brought by Chapter 7 Trustee in Delaware and later settled

Construction Litigation:

- Defended mechanical subcontractor from multimillion-dollar lower tier subcontractor delay/interference claim on West Virginia federal prison construction project and correspondingly asserted claims for indemnification against prime contractor that were all resolved successfully in arbitration with contribution by prime contractor
- Successfully defended subcontractor client from environmental damage claim in Colorado by prime contractor and owner on highway project, pursued claims against lower tier subcontractor

and settled without formal litigation for significantly less than the original demand through quick and efficient use of mediation

- Guided subcontractor client through multiple issues caused by lower tier subcontractors' default and pursued rights and remedies against the lower tier subcontractor surety, all resulting in no work stoppage on \$1 billion dollar federal government contract in Manhattan, Kansas and recovered all funds due to client
