- Won a lawsuit challenging a state license that allowed an automobile manufacturer to sell its electric cars directly to Missouri consumers.
- Obtained relief from decisions to deny, revoke, and discipline numerous licenses, including those for long-term care and day care facilities, a funeral director, nursing home administrator, veterinarian, casino positions, accountants, and nurse.
- Obtained complete relief for a major health care provider in litigation over a state services contract.
