investors and management was severely challenged. The receivership allowed a 'safe' period during which the operations became stabilized.

- Represented a Chapter 11 debtor that was a large regional provider of oilfield fluid transportation services. There, the debtor had purchased its company soon before the 2008 - 2009 downturn, from a promoter who had misrepresented the scope of the liabilities and overstated the assets. The individual owners and the company were liable for significant tax obligations. The result was a restructured company, downsized to a level where a successful reorganization was accomplished with the infusion of new capital.
- Represented a Chapter 11 debtor that owned a national restaurant brand with operations throughout the country. There was considerable pressure from diverse credit facilities with varied interests and goals. This operation was downsized with a spinoff of various operations in a market-specific approach, in some cases, closing stores, in others, rebranding stores, and in others, successfully selling participate markets. The reorganize was successful and the reorganized company continues today as an entirely rebranded construct.
- Represented both debtors and creditors in hotel related reorganizations.
- Served as counsel to many close-held businesses with debts ranging from \$10 - 100 million. In many of these instances, internal controls and management were placed to guide the clients through the restructuring process. Many of these result in negotiated reorganizations outside of the bankruptcy context.
