

## Lathrop Gage Obtains Women in Law Empowerment Forum's 2015 Certification

**KANSAS CITY, Mo. (June 25, 2015) -** Lathrop Gage is proud to be listed among the top firms in the nation for female equity and power. The Women in Law Empowerment Forum (WILEF) granted 44 firms with its 2015 WILEF Gold Standard Certification, emphasizing the leadership roles achieved by equity women partners.

The 2015 WILEF Gold Standard Certification is granted only to firms that successfully demonstrate that women represent a meaningful percentage of their equity partners, highest leadership positions, governance and compensation committees and most highly compensated partners. This certification highlights the value that Lathrop Gage places on women in the firm by supporting them in their leadership positions including partnership, executive committee roles and practice team leads.

In order to achieve this certification, firms with at least 300 lawyers had to meet at least four of the following six criteria:

- 1. Women account for at least 20 percent of equity partners or, alternatively, 33 percent or more of the attorneys becoming equity partners during the past twelve months.
- 2. Women represent at least 10 percent of firm chairs and office managing partners.
- 3. Women make up at least 20 percent of the firm's primary governance committee.
- 4. Women represent 20 percent or more of the firm's compensation committee.
- 5. Women make up at least 25 percent of practice group leaders or department heads.
- 6. Women represent at least 10 percent of the top half of the most highly compensated partners.

Lathrop & Gage welcomes the 2015 WILEF Certification and will continue to implement strong diversity efforts and lead by example as an advocate for women in the legal industry.
